## **Planning Commission Meetings**

## **Flood Advisory Committee Meetings**

The City Flood Advisory Committee meets typically during flood events.

## **City Structure**

The City of Lake St. Croix Beach functions in a weak-mayor system, the Mayor has no formal authority outside the Council; the Mayor cannot directly appoint or remove officials, and lacks veto power over Council votes.

The weak-Mayor form of government is found in small towns in the United States that do not use the more popular council-manager form used in

most municipalities that are not considered large or major cities, and is frequently seen in small municipalities with few or no full-time municipal employees.

The current Mayor, Tom McCarthy, while retired, is a "working Mayor." Many of the tasks done in the City throughout the year such as - raising and lowering the flags, putting up the weight restriction signs, cleaning debris away from drains and fire hydrants, the list goes on and on - are done by Mayor Tom.
